Member absent Schneider., Also in attendance were: Commissioner Johnson, Douglas, County Lake Association Board Member, Linda Dokken-McFann, Haggenmiller, Dybdal and Arceneau.

Treasurer's Report was read. <u>Motion by Wolf to approve, subject to audit, seconded by Rutten</u>. Motion carried.

Reports

- **A. Coordinator's Report –** No Report was given.
- **B. Pomme De Terre-** No report was given.
- C. Douglas County Commissioner Report-Commissioner Johnson mentioned the April 19th task force meeting to review the Hospital being State vs. County owned. The County should know by July 1st if the State approved the takeover. Johnson also discussed the offsetting of Nitrogen that is contributing to poor water quality in the Chippewa River. The Construction plans have been laid out thru 2017, the 2016 Fresh Water Society Conference at Arrowwood is scheduled for April 15 & 16.

- **A. Native Grass Seeding Selling** Haggenmiller mentioned there was a complaint that the District is selling premix seed to landowners. After discussion the Board approved by general consensus to continue the selling of premix seed.

first round, 1 application will be ranked for the 2nd round of EQIP, CSP signup is March 31st, and Meissner is working on twelve CRP applications. A new Soils Conservationist will arrive in May.
