A. NRCS Field Office Cole Montgomery mentioned that the State Conservationist Troy Daniels stopped by the office last Monday on his way up to Detroit Lakes. They gave him a tour. The Team Leads & State Leadership had a meeting last Tuesday regarding FY26 EQIP. The official sign-up date for FY26 EQIP will be August 1st, and

the ranking deadline will be before Xmas. The payment caps+ payment rates are likely to be reduced & there will be heavy screening. We received another \$1.5 million in EQIP dollars to Douglas County applications last week. We should push us to about \$4.5 million in EQIP/CSP here for the year. Have until the end of the month to get those obligated. Almost 100% complete & paid out on scheduled spring practices for the year. The warm season seeding deadline was extended to July 14<sup>th</sup> - still have a couple of those that need to be completed. Pasture items & pit closures have been steadily getting completed as well.
